

## **Mobile Application Privacy Statement**

This Financial Independence Group, LLC ("FIG") Mobile Application Privacy Statement ("Mobile Privacy Statement") explains the data FIG may collect when you to use a FIG mobile application (or "App").

Downloading, accessing, or otherwise using the App indicates that you have read this Mobile Privacy Statement and consent to its terms. If you do not consent to the terms of this Mobile Privacy Statement, do not proceed to download, access, or otherwise use the App.

FIG may collect the following information through the App:

- Personal information you may provide to download and use the App, including your email address, name, and password;
- Information about your usage of the App, including crash logs and usage statistics;
- Information about your device and its interaction with the App, including the type of mobile device you use with the App, its unique user ID, IP address, and operating system, and the type of mobile Internet browsers in use; and
- Information about the location of your device, including geo-location information.

FIG may use the information collected through this App in the following ways:

- To review the quality and improve the functionality of the App;
- To better improve the way the App works with your device;
- To create new Apps;
- To provide anonymized user analytics and industry benchmarking; and
- To share anonymized data with third-parties.

Provided that this information is not required to be retained pursuant to judicial proceeding, court order, or legal process, this information will be deleted when it is no longer needed to provide the services associated with the App, unless it has been anonymized and does no longer contain personally identifiable information.

FIG may use cookies and/or other web tracking technology through this App. While Apps at this time do not recognize automated browser signals regarding tracking mechanisms, such as 'do not track" instructions, you can generally express your privacy preferences regarding the use of most cookies and similar technologies though your web browser. You consent to their use by using this App.
